REGULATIONS

National exhibition with international participation "AEROMFILA 2020" XXXVI edition

I. PURPOSE, ORGANIZATION, PARTICIPATION

Art.1 National exhibition with international participation "AEROMFILA 2020" marks the accomplishment on April 23, 2020, of 100 years since the creation of the FIRST TRANSCONTINENTAL - INTERNATIONAL AIR-CRAFT IN THE WORLD for passengers, freight and mail: FRANCO-ROMANIAN AIR NAVIGATION COMPANY - CFRNA, 50 years of existence of the Aerophilately Commission within the Romanian Philatelic Federation and 50 years since the first edition of the exhibition AEROMFILA.

Art.2 The exhibition, which is at the XXXVI edition, is organized by: Romanian Philatelic Federation - Aerophilately Commission, Museum of Romanian Records, BARTOC Cultural Foundation, between April 23 and 25, 2020 in Bucharest in the Museum of Romanian Records, 25-27 Parfumului Street, under the patronage of AIJP and FISA.

Art.3 "AEROMFILA 2020" exhibition has international participation and will take place according to the Statute of the International Philatelic Federation (F.I.P.) for aerophilatelic, astrophilatelic and philatelic subjects, as well as to our present regulation.

Art.4 Air philatelic and astrophilatelic collections with air and flying subjects could participate in this

exhibition.

a) Individual collectors, members of the Romanian Philately Federation, members of all national philately associations, members of the International Federation of Aerophilately;

b) Air companies.

Members of the jury, as well as their families may show their collections but only hors-concours.

Art.5 An exhibitor can participate with one or more exhibits only if he received at least one silver medal at a national or international exhibition.

Art.6 All the exhibits presented will be exclusively the collector's property.

Art.7 The organizing committee reserves the right to decide whether a collection can be exhibited in full, in part, for the first time, or not at all, without justifying its decision.

II. PARTICIPATION CLASSES

Art.9 The "AEROMFILA 2020" exhibit has the following participation classes:

A) Class of honor - for collections having awarded a great prize, gold or a gold rank diploma in one of the national or international exhibitions.

B) Hors-concours - for the collections belonging to the members of the jury and their families or to some collectors who had made special request for that.

C) Competition class - for the participants of our country or abroad both young and adults. There are the following groups:

Ist Group - aviation pioneers, forerunners, attempts, records, meetings, and races.

Ind Group - air mail using other means (of transport) than planes (pigeons, balloons, helicopters, airships, rockets, etc.).

Illra Group - development of air mail and transportation by common and special flight

IVth Group - air companies

a) in Romania;

b) in other countries

Vth Group - military air mail postal service

VIth Group - special collections (air crashes, night flight, air Olympics)

VIIth Group a) postal stationery

b) - special aero philatelic cancellations, aerogramme, vignettes, card collecting

VIIIth Group - astrophilately collections:

a) astronomy and astronomy research;
b) astronautics and space research

IXth Group - air mail stamps (general collections, collections on the continents)

Xth Group - systematic collections, according to other criteria

XIth Group - study collections of some air mail issues or collections on some types of aircrafts.

XIIth Group - maximum cards, air philately, air maximum cards

XIIIth Group - revenue stamps collections

XIVth Group - OPEN

XVth Group - picture postcards

XVIth Group - Youth

XVIIth Philatelic and astrophilatelic literature

a) books, magazines, studies and research in the special branch;

b) catalogues and prospectuses;

c) documentaries

III. CIRCUMSTANCES OF PARTICIPATION

Art.10 The collectors shall request participation through a registration form, which shall include the following data: name and surname of the collector, the exact address, class, section and Group to which he requests to exhibit his collection, the title of the exhibit, prizes awarded before, the number of frames requested to shown the collection. The exhibitors from the youth section will necessarily specify the date of birth.

^{*} Note: the exhibits of 1 frame can participate in any of the 16in groups of class (C) of competition as well as class B.

All exhibitors' requests should be sent by e-mail to the address: fundatiabartoc@gmail.com and in BCC federatia filatelica@yahoo.com by 10 February 2020 at the latest.

Art.11 A collection shall include a minimum of 5, a maximum of 8 exhibit frames, with 16 album sheets size A4 (21cm x 29 cm). For youths, the minimum of frames is 3.

Each exhibit sheet has to be protected by a protection envelope, well shut and transparent, and on the reverse of the sheet the name, surname and address of the collector must be written. The exhibit sheets corresponding to a frame shall be packed in a distinct envelope.

Art.12 Exhibitors who received the Grand Prize at FIP exhibitions worldwide or FEPA / FIAP / FIAF continental exhibitions, cannot participate in any competition class. They can participate in class 9A.

Art.13 The organizing committee will confirm in writing by email, the acceptance of the collections by February 24, 2020.

Art.14 By signing the registration form, the exhibitor confirms the veracity of all the completed data and compliance with the exhibition regulations and assumes its responsibility to the CO to participate in the exhibition.

IV. PRESENTATION OF COLLECTIONS

- Art.15 The admitted collections must arrive personally or through a delegate for the Romanian exhibitors, until April 10, 2020, and foreigners through the national commissioner until April 22 at the headquarters of the Romanian Record Museum, Parfumului Street 25-27, Bucharest 030167.
- Art.16 Participation in the exhibition "AEROMFILA 2020" is free. The costs of sending and providing the exhibits are suported by the exhibitors.
- Art.17 The exhibits will be returned to the national commissioner at the closing of the exhibition and to the Romanian exhibitors personally or to a delegate within 30 days from the closing of the exhibition.
- Art.18 The collections sent to the Organizing Committee will be accompanied by an inventory that will be drawn up in four copies of which one signed on receipt of the exhibit is returned to the exhibitor.

The inventory will include, in the order of the exhibition sheets, the number of postage stamps and other pieces.

- Art.19 The philatelic materials can be signed with a soft pencil (on their reverse) by the collection owner.
- Art.20 Forgeries or stamps rejected by International Philately Federation or Romanian Philatelic Federation cannot be presented in the exhibit.

V. EXHIBITION JURY

Art.21 The jury of the exhibition "AEROMFILA 2020" will be made up of 5 members with a deliberative vote and 1 secretary who has a consultative vote regarding the appreciation of the exhibited collections. The jury members may also be commissioners. The chairman of the jury will be appointed by the Executive Committee of the F.F.R.

Art.22 The decisions of the jury are taken by majority vote and without motivation.

VI. DISTINCTIONS AND AWARDS

- Art.23 The criteria for appreciating collections are those established by the International Philately Federation for international and thematic exhibits
 - Art.24 The Organizing Committee, on the basis of the jury decisions shall award the following distinctions in rank of:
 - a) gold medal: 90-94 points;
 - b) large vermeil medal: 85-89 points;
 - c) vermeil medal: 80-84 points;
 - d) large silver medal: 75-79 points;
 - e) silver medal: 70-74 points;
 - f) silver bronze medal: 65-69 points;
 - g) bronze medal: 60-64 points;
 - h) certificate of participation: < 60 points.

All medals will be made from tombac, each participant will receive one medal (participants with more than one exhibit will receive only one medal).

Art.25 The following awards will be awarded at the "AEROMFILA 2020" philatelic exhibition:

a) The prize for the best exhibited by Romanian air mail, granted by Art Group INT;

b) Prize of the exhibition for the best exhibit of general air mail, granted by the BARTOC Cultural

Foundation;

- c) The prize for the best astrophilately exhibit, granted by the BARTOC Cultural Foundation;
- At the same time, prizes can be awarded by institutions, organizations, airlines and philatelists.
- Art.26 The members of the Honor and Support Committee, the Organizing Committee, the jury, are awarded the diploma of honor and the exhibition medal.
 - Art.27 The organizing committee will make every effort to ensure the security of the collections.

Each exhibitor must personally insure their collection.

Art.28 If the exhibits are from non-EÚ countries, the collections must be sent or brought with an "ATA booklet". An inventory form must be prepared for exhibits in accordance with Romanian customs regulations.

VII. FINAL DISPOSITIONS

Art.29 The organizing committee will publish the catalog, envelope and palmares of the exhibition, which will be distributed free of charge to all exhibitors and members of the exhibition bodies.

Art.30 By completing the registration request, it is considered that the solicitant is aware of the regulation and grants his complete consent.

Art.31 The Organization Committee reserves the right to bring any eventual modifications or completions to these regulations. These will be brought to the attention of participants in due time.
