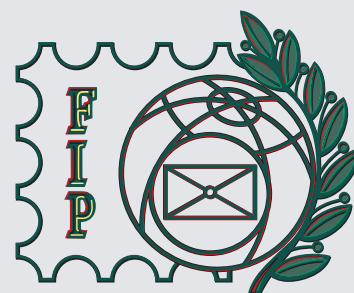

## Editorial

The highlights regarding the recent FIP Board of Directors Conference meetings report some novelties to be carefully read, especially regarding the updated regulations for the Commissions to hold a FIP Qualifying seminar at both FIP Patronage and FIP Recognition exhibitions. A comparison of the various FIP exhibitions is also presented in order to make clear the differences and implications.

The preparations for the 2026 activities for the FIP hundredth anniversary have started. If you would like to propose to Postal Administrations that the FIP Centenary logo appears on some of their products or if the logo is to be printed on advertisements or publications, please read carefully the related terms of usage.

For those who did not participate to the FIP 2024 Congress in Shanghai, a brief report highlights the main topics that were discussed there. The FIP Board has also decided that the 2026 FIP Congress will be held in Macao on July 1.

In this issue of FLASH you will be pleased to read a report on the FIAP 2024 Shanghai exhibition that has attracted more than 100,000 visitors. It is followed by an extensive report about the successful FIP Exhibition in Punta del Este, Uruguay, the first to be held in South America outside of Brazil. Two very well attended FIP Qualifying seminars were also held there.

The next FIP Patronage exhibition is the PHILAKOREA 2025 one, postponed from 2024, and useful details about the preparation are presented. Also Birmingham 2025, under FIP Recognition, with more than 2,000 frames is just about to welcome participants and some last details are presented.

Last November an important FIP-sponsored regional exhibition was held in Thessaloniki, Greece. The twentieth Balkanfila proved to be an interesting and very pleasant exhibition, thanks also to the proverbial Greek hospitality.

FIP Board is considering a possible experimental First Day Cover class in future FIP Patronage Exhibitions. In this respect please read carefully the article by Colin Fraser on "Collecting and Exhibiting First Day Covers".

Have a pleasant reading and looking forward to seeing many of you in Birmingham and/or in Seoul!

En este número de FLASH, les complacerá leer un informe sobre la exposición FIAP 2024 en Shanghái, que atrajo a más de 100.000 visitantes. A continuación, se incluye un extenso informe sobre la exitosa Exposición FIP en Punta del Este, Uruguay, la primera celebrada en Sudamérica fuera de Brasil. Allí también se celebrarán dos seminarios de clasificación FIP con gran asistencia.

La próxima exposición patrocinada por la FIP es PHILAKOREA 2025, pospuesta para 2024, y se presentan detalles útiles sobre los preparativos. The 77<sup>th</sup> FIP Congress held in conjunction with CHINA 2024 the 40<sup>th</sup> Asian International Exhibition with FIP Recognition in Shanghai on 3 December 2024, went well with participation from FIP Members. The FIP Board appreciated the keen participation of Members especially from Europe and America, who came to attend the Congress even though they were not Exhibitors, Commissioners nor Jurors.

The FIP Board would also like to thank the CHINA 2024 Organising Committee, All-China Philatelic Federation, for kindly hosting the Congress. FIP appreciated their kind hospitality including hosting the delegates to the Palmares, providing the airport transfers to the official hotel, and making arrangements for the Congress venue, coffee breaks, lunch buffet and set up.

FIP welcomed Morocco as the new FIP Member, their FIP Membership application of which was unanimously approved by the Congress.

The Congress had also confirmed the provisional FIP Patronage given by the FIP Board for EFIRO 2024 and URUGUAY 2025, and approved the FIP Patronage for DUBAI 2026, MACAO 2026, PHILATAIPEI 2026, BELGRADE 2027 and SLOVFILEX 2027.

FIP awarded the FIP Medal for Exceptional Jury Service to two outstanding Jurors - FIP Honorary President Koh Seow Chuan (Singapore) and former FIP Vice-President Raymond Todd (Australia).

The first FIP Patronage Exhibition in 2025, URUGUAY 2025 Specialised World Stamp Exhibition, was held in Punta del Este from 17-22 February 2025. Our heartiest congratulations to the Organising Committee of URUGUAY 2025. Two FIP Qualifying Seminars were also conducted by the Postal Stationery and Open Philately Commissions.

The next FIP Patronage Exhibition in 2025 will be PHILAKOREA 2025 Specialised World Stamp Championship to be held from 17-21 September 2025. The PHILAKOREA 2025 Organising Committee are ready to support other important philatelic activities such as FIP Qualifying seminars and a possible FIP Jury Academy, if there are sufficient participants to make up the class.

At the recent 182<sup>nd</sup> Board meeting on 20 March 2025, the FIP Board had approved MACAO 2026 to host the 78<sup>th</sup> FIP Congress, updated the FIP Commission Guidelines for greater flexibility, and also approved the appointment of a working group on a possible First Day Cover experimental class led by the Vice-President Yigal Nathaniel.

We encourage all FIP members to participate in the upcoming signed FIP Patronage Exhibitions PHILAKOREA 2025, DUBAI 2026, MACAO 2026, PHILATAIPEI 2026 and BELGRADE 2027.

In addition to the FIP Patronage exhibitions, we also have two upcoming FIP Recognition Exhibitions - EUROPHILEX 2025 under FEPA Patronage this 7-11 May 2025, as well as BOSTON 2026 WORLD EXPO FIAF Patronage.

We looked forward to seeing all philatelists and visitors at these FIP Patronage and FIP Recognition Exhibitions which we believe they will enjoy very much.

Se otorgó la Medalla FIP por Servicio Excepcional como Jurado a dos jurados destacados, el Presidente Honorario FIP, Koh Seow Chuan (Singapur) y el ex Vicepresidente FIP, Raymond Todd (Australia).

La primera Exposición con patrocinio FIP del año 2025, la Exposición Mundial Especializada URUGUAY 2025, se celebró en Punta del Este del 17 al 22 febrero. Nuestras más sinceras felicitaciones al Comité Organizador. También se llevaron a cabo los seminarios de calificación FIP para las clases de Enteros Postales y Filatelia Abierta.

## Highlights of the 177<sup>th</sup> FIP Board of Directors Conference Meeting on 5 November 2024

### EXHIBITIONS

#### CHINA 2024 (FIP Recognition)

Vice-President Tan updated that the FIAP continental jury training shall proceed, out of which two participants were jury apprentices attending as observers only and would not be awarded any certificates. He proposed that President Chirakiti be the official observer from FIP and he himself will be the FIAP observer to keep expenses low, which was approved by the Board.

#### URUGUAY 2025

Vice-President Macedo reported that he was in Punta del Este and Montevideo from 18 - 20 October 2025 and the FIP flag was handed over to the Organising Committee. The frames were at the final stage of preparation, with many dealers attending and supporting. The international jury team was also discussed and selected based on the GREX.

#### PHILAKOREA 2025

Vice-President Tan updated that the Commissioner General sent the invitation to all FIP Members to confirm their previous nomination of jurors and appointment of National Commissioners.

#### DUBAI 2026

President Chirakiti updated that Director Khoory had kindly negotiated with the Organising Committee to re-schedule the exhibition from October 2025 to February 2026 to avoid being too close to another possible FIP Patronage exhibition in October 2025. The official letter had been circulated to the Board, which the Board members unanimously approved the provisional Patronage for DUBAI 2026. The Emirates Philatelic Association would make a presentation at the 77<sup>th</sup> FIP Congress for official approval of the Patronage.

#### MACAO 2026

Director Khoory updated that he was finalizing the IREX and a presentation by the Organising Committee shall be made during the Congress in Shanghai.

#### BELGRADE 2027

Director Suhadolc updated that the Organising Committee would shift the exhibition dates to October 2027 and make a short presentation of the exhibition during the Congress.

#### SLOVILEX 2027

The Secretary General had circulated the official letter from the Union of Slovak Philatelists to the Board to seek the Board's approval on their request to host a FIP Patronage Specialized World Stamp Exhibition in mid 2027. The Board members unanimously approved the provisional Patronage of SLOVFILEX 2027 and appointed Vice-President Nathaniel as the FIP Consultant.

### 77<sup>th</sup> FIP CONGRESS

#### WITHDRAWAL OF MOTION FROM APS

The Secretary General updated that the American Philatelic Society had withdrawn their Motion as the Federation's delegate was unable to attend the Congress.

### 77<sup>th</sup> FIP CONGRESS

Vice-President Macedo discussed with the Board members on the final changes to the international jury team for the exhibition.

## Highlights of the 179<sup>th</sup> New FIP Board of Directors Meeting in Shanghai on 3 December 2024

### NEW FIP BOARD

President Chirakiti welcomed and congratulated the re-elected Vice-Presidents Yigal Nathaniel and Aldo Samamé y Samamé as well as Directors Reinaldo Macedo and Peter Suhadolc to the Board. The responsibilities for each of the Board Members were discussed and finalised.



## Highlights of the 180<sup>th</sup> FIP Board of Directors Conference Meeting on 9 January 2025

### EXHIBITIONS

#### URUGUAY 2025

Director Macedo proposed that considering two Board members and the Secretary General would not be present in Uruguay, he suggested no Board meeting at the end of the exhibition. The approval of the two apprentice jurors, would be ratified at the next FIP Board meeting.

#### PHILAKOREA 2025

Vice-President Tan reported that the official hotel would be Ambassador Mercure which was just beside the exhibition venue and to-date 60 countries had responded to the Organising Committee.

#### BOSTON 2026 (FIP RECOGNITION)

The Board members reviewed the invitation letter that had been sent out as well as the advertisement copy received for FLASH and agreed that some information had to be clarified by the FIP Liaison officer to the Organising Committee for correction in Uruguay.

### REGULATIONS

#### GREX

The Board members approved to add the elaborate on GREX 5.3 Competitive Promotional Classes as

*“Any other exhibit promoting philately and stamp collecting with content up to one third non-philatelic materials and materials from non-postal authorities to supplement the philatelic materials.”*

This shall have to be ratified at the 78<sup>th</sup> FIP Congress.

### JURORS

#### FIP QUALIFYING SEMINARS

President Chirakiti prepared and circulated to the Board the proper procedures for the FIP Commissions to decide on the details of the FIP Qualifying Seminars for discussion. It was concluded as follows to be circulated to all the Commissions by the Secretary General:

#### FIP Qualifying Seminars

**As participation to FIP Qualifying Seminars is one of the key requirements for jury apprenticeship, the FIP Board has the responsibility to ensure the Organising Committee (OC) and Commissions had done proper planning with sufficient lead time for announcement to those who would like to attend in accordance with current regulations:**

**1 the FIP Consultant** of an Exhibition should try to make the planned timetable for both Jury and Commissioner available for approval by the Board at least **two months** prior to the exhibition so that there is sufficient time for the Secretary General to inform all Commissions to plan with their Bureau on the FIP Qualifying Seminars for that Exhibition.



Timeslots for the Seminars are usually the day after end of Jury Work, before the Palmares so that all Jurors and Commissioners, other than exhibitors, can attend. The FIP Coordinator assigned to each Commission must be available and present to listen to the content and to ensure that attendees are present throughout, especially in the case of FIP Qualifying Seminars. No Board meetings, Jurors' or Commissioners' activities should be planned at the time of FIP Qualifying Seminars, if possible.

FIP Qualifying Seminars can also be organized at FIP Recognition exhibitions. The FIP Liaison officer to the Recognition exhibition must plan in advance with the OC as per above.

As the FIP Coordinator to a Commission conducting the FIP Qualifying Seminar may not be at the Recognition Exhibition to observe the participation of attendants; the Seminar contents and Q&A, the FIP Directors of that respective Continent should, in this case, do that on behalf of the FIP Coordinator.

**2** the respective FIP Coordinator to follow up with their respective Commissions in advance if they wish to hold the FIP Qualifying Seminar for the upcoming Patronage or Recognition Exhibitions and ensure that the decision process is according to the current regulations.

**3** if a Commission wish to propose a FIP Qualifying Seminar for the upcoming Patronage or Recognition Exhibitions, then the details must be discussed by the Bureau and have to be proposed to the Board for approval and the FIP Consultant can confirm the timeslots with the OC and the Secretary General, who will announce them on the FIP website at least **one month** before the Exhibition.

**4.** General Lecture contents to educate exhibitors can be proposed by the Commission Chairman to the FIP Coordinator to the Commission and arranged with the FIP Consultant of the exhibition if timeslots are available and reported by the Coordinator to the Board.

## EXHIBITIONS

### URUGUAY 2025

As the Open Philately and Postal Stationery FIP Qualifying Seminars were proposed at quite short notice from the date of the exhibition, after some discussions, they were approved by the majority of the Board.

### BOSTON 2026

As FIP Recognition was given to "BOSTON 2026 World Expo" under FIAF Patronage, but not including the Champion of Champions, Polar Salon, German American Salon, it was agreed that the FIP Liaison Officer would highlight it to the Organising Committee in Uruguay.

## Highlights of the 182<sup>nd</sup> New FIP Board of Directors Conference Meeting on 20 March 2025

### 78<sup>th</sup> FIP CONGRESS

The Board members approved the application by Clube Filatélico de Macau and Organising Committee of MACAO 2026 to host the 78<sup>th</sup> FIP Congress to be held in Macao, during MACAO 2026 FIP Specialised World Stamp Exhibition.

## EXHIBITIONS

### PHILAKOREA 2025

Progress of the exhibition was reported to the Board. The official hotel had been finalized.

### DUBAI 2026

President Chirakiti reported that the official hotel had been confirmed and invitations were sent out to all Members.

### PHILATAIPEI 2026

President Chirakiti reported that the IREX were being finalized and invitations will be sent out soon.

**BELGRADE 2027**

Director Suhadolc updated that the Organising Committee was finalizing the official logo as well as in the midst of selecting the official hotel. He shall be meeting them personally the day after and shall keep the Board informed.

**MEMBER FEDERATIONS**

The Secretary General had started to send out the invoices and FIP Awards List as at URUGUAY 2025 to the Member Federations.

**EXHIBITS****POSSIBLE FIRST DAY COVER EXPERIMENTAL CLASS**

Vice-President Nathaniel discussed with the Board regarding a possible experimental First Day Cover class in future FIP Patronage Exhibitions. It was agreed that there was a need to harmonize the different judging guidelines amongst various countries for the First Day Cover exhibits at FIP level. President Chirakiti proposed that Vice-President Nathaniel form and lead a working group for further discussion.

**FIP EXHIBITIONS**

The comparison chart on the differences FIP Patronage and FIP Recognition Exhibitions were reviewed to make the details clearer and approved by the Board. For details see pages 11-13.

**FIP SPONSORSHIP**

Board members unanimously approved the application by the Asociacion Filatelica Peruana to apply for 2025 FIP Sponsorship of US \$5,000 for regional exhibition AMILFIL 2025 to be held in Lima, Peru from 14 – 19 October 2025. The exhibition shall be participated by nine countries with more than 400 frames.

**COMMISSIONS GUIDELINES**

President Chirakiti proposed a few more updates to the Commissions Guidelines, in consideration of the feedback from the Commissions regarding the previous proposed changes that had been sent to all the Commissions. The updates were approved by the Board members.

**FIP GPC****FIP GPC Lunch at Punta del Este, Uruguay**

Members of the FIP Grand Prix Club, along with their families, gathered on 22 February, 2025 at a charming beachfront restaurant in Punta del Este kindly arranged by Mr Everaldo Santos. This is tradition at every FIP World Stamp Exhibition, where members who are present in person would congregate for lunch in an atmosphere of camaraderie and friendship, strengthening bonds among collectors from around the world.

The 77th FIP Congress was held in Shanghai on 3 December 2024 at the Shen Ballroom of the Portman Ritz-Carlton Hotel.

FIP President Chirakiti gave a warm welcome to all delegates thanked the CHINA 2024 Organising Committee's support in making the Congress possible.

*13.3 A F.I.P.-Member, not having nominated a regular delegate to a Commission/Section before the request for nominations for Chairman, Secretary and members of Bureau has been issued, may not appoint a delegate solely for the purpose of voting in the election.*

The First Letter for the Congress with further details and all the necessary nomination forms to the FIP Board and FIP Commissions' Bureaux, shall be sent out to Members before **30 September 2025**.

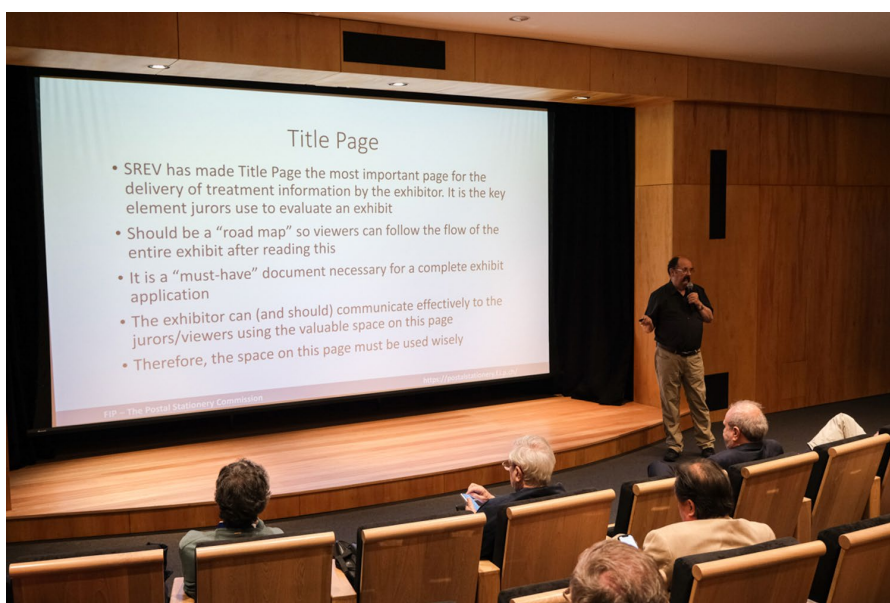
## FIP Postal Stationery Qualifying Seminar at URUGUAY 2025

The Postal Stationery Commission held a FIP Qualifying Seminar on Wednesday, 19 February 2025 from 15:15 to 16:30 at the Museo de Arte Contemporáneo Atchugarry (MACA) Auditorium in conjunction with Uruguay 2025 at Punta Del Este, Uruguay.

In the first part of the seminar, the Commission Chairman, Ian McMahon from Australia, presented on Judging Postal Stationery and Current Trends in the Postal Stationery Class including: General Principles, Judging Criteria and Scoring, Condition, Rarity and Importance, Knowledge and Research, Presentation, Feedback and Expectations of Postal Stationery Judges.

The second part of the seminar was presented by Bureau Member, Ross Towle from the USA and covered Postal Stationery including: Treatment – the SREVs and Guidelines, the Title Page, Purpose, Flow and Balance and Postal Stationery Treatment.

The seminar was well attended with 38 attendees in addition to the presenters.



## FIP Open Philately Qualifying Seminar at URUGUAY 2025

An official Open Philately (OP) FIP Qualifying Seminar was held on February 19th at the FIP Specialized World Stamp Exhibition in Punta del Este, Uruguay. The event attracted a record number of local and international participants, with 48 attendees eager to engage with OP!

The seminar was led by FIP Board Member Peter Suhadolc, with assistance from Jari Majander, who represented OP exhibitors. Both are members of the FIP Open Philately Working Group (OP WG), the provisional commission chaired by Birthe King. The key topics covered during the seminar included:

- A presentation on the current Guidelines for judging OP, outlining the evaluation criteria and showcasing example pages from award-winning OP exhibits.
- A comparison between the existing Guidelines and the new SREV and Guidelines proposed by the OP WG.

Since OP exhibits are expected to include both philatelic and non-philatelic items - with the majority being philatelic - the proposed SREV and Guidelines provide definitions for distinguishing philatelic items and practical guidance for assessing their predominance. Rather than counting individual items or measuring the space they occupy on the pages, it is encouraged to step back and look at the whole exhibit frame by frame. In most cases, it becomes readily apparent whether the balance favours philatelic material.

Although a dedicated Q&A session was planned for the end of the seminar, many questions arose throughout the presentation, including the use of various non-philatelic items and what can or should be included in OP exhibits. For example, are printouts from the web permissible in OP exhibits? While the guidelines do not explicitly prohibit such items, exhibitors are encouraged to prioritize original collectible materials over reproductions. To emphasize this point, the example pages featured a remarkable selection of significant non-philatelic collectibles, including medals, coins, degrees, lithographic prints, and propaganda posters.

A frequently discussed topic in OP seminars is the role of picture postcards in OP exhibits. The franking side of a used postcard is classified as philatelic, while the non-franked side is considered non-philatelic. However, in most cases, it is primarily the picture side of the postcard that contributes to the exhibit's narrative. Consequently, picture postcards are typically regarded as nonphilatelic in OP exhibits, as the address side generally holds no significance to the story being told. This limitation can be avoided by displaying postcards that are franked on the picture side.

The remarkable turnout at the seminar held during URUGUAY 2025 and the lively discussions are strong evidence that OP is advancing and gaining momentum among philatelists, potential exhibitors, and FIP jurors seeking accreditation in OP. The proposed new SREV and Guidelines were well received by the participants.

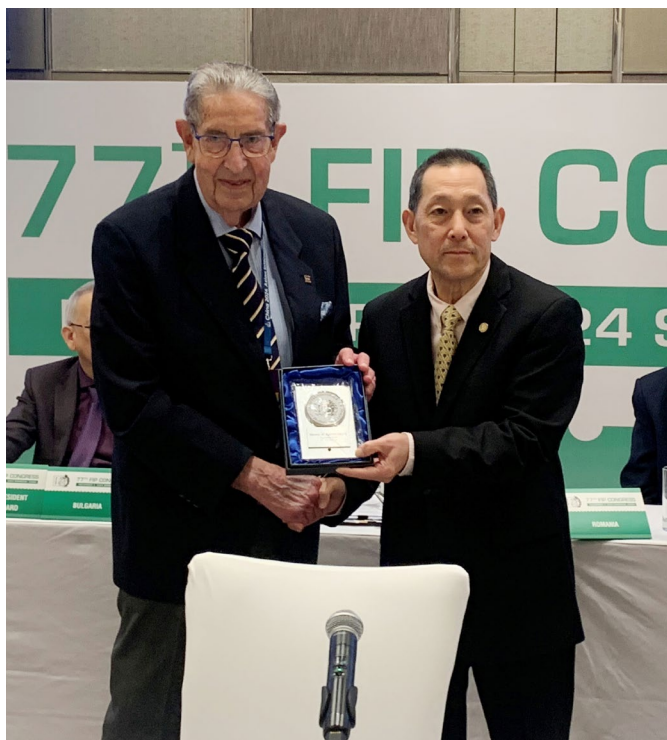


## FIP Medals for Exceptional Jury Service

FIP Director Suhadolc introduced that Charles had served in FIP exhibitions as FIP juror for 15 times from 1997 to 2025 in the Traditional, Postal History and Literature classes. He had also served as Team leader, Jury Secretary and Jury President in several exhibitions respectively.

Charles was also one of the lead FIP Jury Academy Trainers and Curriculum Developer, as well as a Jury Academy Trainer. He had also been involved in helping to consolidate the past Congress documents for the 100<sup>th</sup> Anniversary of FIP coming up in 2026.

## FIP Recognition China 2024 Asian International Stamp Exhibition

China 2024 Asian International Stamp Exhibition was held from November 29 to December 3, 2024, at the Shanghai Exhibition Center. This event was hosted by the State Post Bureau of China and co-organized by Shanghai Municipal Transportation Commission, Shanghai Jing'an District People's Government, China Post Group Corporation Limited, and All-China Philatelic Federation.

Themed "Stamps Present Asian Culture," the exhibition aimed to expand and develop friendly relations and close cooperation among FIAP members, promote every aspect of philately in the FIAP region, commemorate the 75th anniversary of the founding of the People's Republic of China, and commemorate the 50th anniversary of the founding of the Federation of Inter-Asian Philately.

In total over 323 exhibits in around 1,617 frames plus 49 literature exhibits were displayed, covering 16 competitive classes: FIAP Championship, Traditional, Postal History, Postal Stationery, Aerophilately, Astrophilately, Thematic, Maximaphily, Revenue, Modern Philately, Picture Postcard, Open Philately, Youth, OFE, Literature, and Experimental Class—First Day Cover, which was introduced for the first time as a competitive class in a FIAP exhibition.

Altogether, 29 FIAP members participated in the competitive exhibition, and there were 120 international and domestic sales booths. The event attracted over 100,000 visitors.

The Jury consisted of 54 members, with Dr Prakob Chirakiti as Honorary President, Mr Tay Peng Hian and Mr Surajit Gongvatana as Senior Consultants, and Mm Jiao Xiaoguang as Jury President. A total of 21 Large Gold medals and 40 Gold medals were awarded.

The exhibition featured five theme days: Opening Day, Shanghai Culture Day, Youth Day, Palmares Day, and FIAP Day. China Post Group Corporation Limited issued a set of four commemorative stamps and one souvenir sheet for this event.

During the exhibition, the Organizing Committee arranged a visit to the Shanghai Museum for Commissioners. A special display area showcasing the Shanghai Youth Post Office was set up at the exhibition hall. On Youth Day, a philatelic lecture for youth collectors was held, and the 4th Shanghai Letter-Writing Culture Festival was launched. The festival aimed to guide young people to showcase Shanghai's historical culture and local customs through letters and help the younger generation rediscover the charm of traditional correspondence.

## FIP WSE URUGUAY 2025

From February 17 to 22, 2025, Uruguay hosted a historic event: the "FIP WSE URUGUAY 2025 – 200 Years of the Declaration of Independence", which took place at the prestigious Atchugarry Museum of Contemporary Art (MACA) in Punta del Este.

This competitive exhibition was the first of its kind in Uruguay and one of the most significant philatelic events worldwide, featuring international jurors and the endorsement of the Fédération Internationale de Philatélie (FIP).



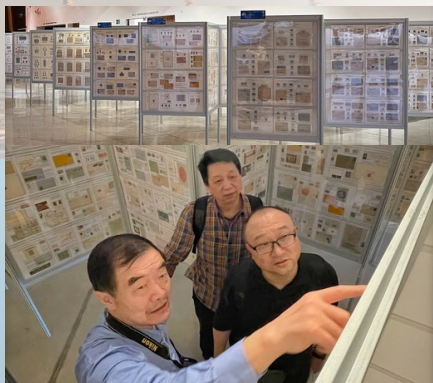

It was part of the celebrations for the Bicentennial of the Declaration of Independence of 1825.

More than 50 countries from all continents participated, showcasing 300 top-tier collections. The event featured international judges and awards for the best collections.

After ten months of hard teamwork, the long-awaited day of the exhibition's inauguration arrived. We were honored by the presence of the FIP President, as well as authorities from UPU, UPAEP, Correo Uruguayo, and various governmental institutions.

The philatelic sheet "Obras de Pablo Atchugarry" was presented to Pablo himself, who served as our host at MACA.

En 1925, se programó el “Vuelo Conmemorativo del Centenario de la Declaración de la Independencia” entre Montevideo y Florida. Sin embargo, ambos vuelos tuvieron problemas mecánicos y la correspondencia tuvo que ser enviada por tierra.

Como parte de la Exposición Mundial “URUGUAY 2025”, se llevó a cabo el “Vuelo Conmemorativo del Bicentenario de la Declaración de la Independencia y el Centenario de los Vuelos Fallidos de 1925”.

Este vuelo conmemorativo (aeronave: Baron 58) operó entre Punta del Este y Florida, regresando luego al Aeropuerto de Punta del Este. Posteriormente, la correspondencia fue transportada en helicóptero hasta el MACA, sede de la exposición, donde funcionarios del Correo Uruguayo y otras autoridades realizaron la ceremonia de matasellado.

Este hecho marcó el primer Vuelo Postal combinado avión-helicóptero en Uruguay, y primero realizado en una exposición mundial. El piloto, Capitán Comandante Retirado de la Fuerza Aérea, Daniel Ubillos, aterrizó en el MACA a las 18:00 del 18 de febrero, donde los visitantes de la exposición recibieron el evento.

In 1925, the “Centennial Commemorative Flight of the Declaration of Independence” was scheduled between Montevideo and Florida. However, both flights encountered mechanical issues, and the correspondence had to be sent by land.

As part of the World Exhibition “URUGUAY 2025,” the “Bicentennial Commemorative Flight of the Declaration of Independence and the Centennial of the Failed Flights of 1925” took place.

This commemorative flight (aircraft: Baron 58) operated between Punta del Este and Florida, returning to Punta del Este Airport. Afterwards, the correspondence was transported by helicopter to the MACA, the exhibition’s venue, where officials from the Uruguayan Postal Service and other authorities performed the stamping ceremony.

This event marked the first combined airplane-helicopter Postal Flight in Uruguay and the first ever conducted at a world exhibition. The pilot, Retired Air Force Capt. Cmdr. Daniel Ubillos, landed at the MACA at 6:00 PM on February 18, where exhibition visitors welcomed the event.



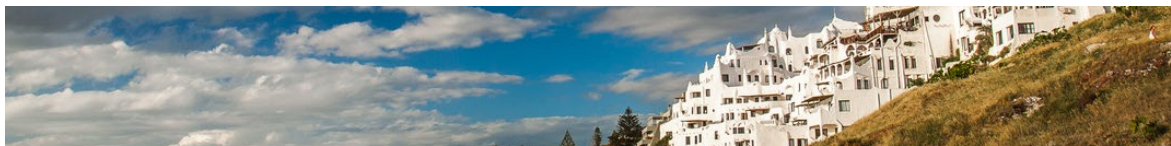

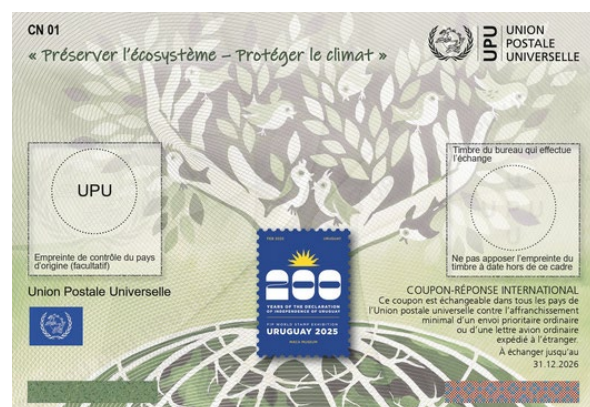
The FUF invited more than 150 of our visitors from all over the world to join a free City Tour around the city of Punta del Este.

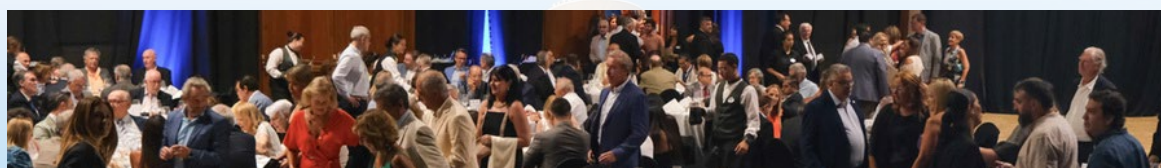

## PHILAKOREA 2025 SPECIALISED WORLD STAMP EXHIBITION INTERIM REPORT

In commemoration of the 140<sup>th</sup> anniversary of the founding of modern postal services, the PHILAKOREA 2025 Specialised World Stamp Exhibition—which was originally scheduled for 2024—had been postponed and will now be held from 17 to 21 September 2025. It should be noted that during the FIP Congress held in Shanghai, China last year, the Korea Post, Korean Philatelic Federation and FIP finalized the contract on 3 December 2024.

The current estimated number of available display frames is approximately 2,000, which is not significantly less than the 2,270 frames (495 exhibits from 66 countries) exhibited in PHILAKOREA 2014, held 10 years ago. The exhibition venue is the COEX exhibition hall located in Magok, Seoul. Although the exhibition infrastructure is excellent and spacious enough, compared to the previous COEX venue in Gangnam which has been used regularly in the past, this location is considerably less accessible to visitors. Without vigorous promotional activities using various media channels, it is by no means easy to secure the expected number of visitors. Moreover, public awareness of stamps has drastically changed over the past decade. Therefore, it is essential that the exhibition is featured at least once on the regular public broadcast at 8 or 9 PM and that persistent efforts—such as installing banners in various strategic locations in cooperation with the Seoul city government—be made.

There is good news that Stanley Gibbons shall allow the Organizing Committee to exhibit the rarest item in the world during the PHILAKOREA 2025 which we hope can attract many visitors.

### Incentivizing Youth Participation

Since the event does not coincide with school vacation periods, it might be more difficult to expect an influx of students who are the future of philately. Therefore, we will try to send official invitations to elementary, middle, and high schools to promote the exhibition as an educational field trip.

### Exhibition Frames

One of the major challenges for Organizing Committees includes securing sufficient exhibition frames. Given usually World Stamp Exhibitions are held only once every ten years, consolidating the frames scattered in various locations into one central pool is no simple task. Even when frames are secured, the high rate of damage means that any shortfall must be compensated for by placing additional orders, which adds on to the costs of the Organizing Committees.

### Submission and Selection of Frames

By early February, a total of 67 countries had registered to participate in the exhibition. Once all submissions from each country are received by the end of February, the selection of exhibits should be completed by April and inform the philatelic federation of the respective countries. The selection of the international jury team shall be done in accordance to FIP regulations with the FIP Consultant to be approved by the FIP Board.

### Domestic Support

The Korea Postal Service Agency (POSA), as was the case 10 years ago, is the organization entrusted by Korea Post to manage the hardware aspects of the exhibition. The Korean Philatelic Federation (KPF), on the other hand, is solely responsible for tasks directly related to philately, such as collecting of exhibits. In this process, members of federation-affiliated organizations are also engaged by volunteering in activities related to the exhibition. The Federation has established five committees to handle different areas:

1. overall planning
2. handling of the exhibits and liaison with National Commissioners
3. exhibition hall management
4. Jury Team and
5. visitors' reception.

These committees not only facilitate smooth coordination between POSA and KPF.

Amongst the five areas, the committee responsible for exhibition hall management is expected to handle the most delicate and sensitive issues and, consequently, requires the largest manpower allocation. In practice, the highest number of personnel is deployed in this area. Moreover, when National Commissioners bring in exhibits from their respective countries for submission, this manpower must address a myriad of detailed requests promptly and accurately—a task that is both labour-intensive and demanding in terms of care.

The reception protocols of the visitors together with VIPs are also critical, as they significantly affect the overall image of the Organizing Committee. Staff who are proficient in foreign languages would have to be assigned for these tasks.

There must be close cooperation with customs officials to ensure smooth customs clearance for the exhibits from all over the world. The Organizing Committee shall also ensure that both the receiving of delegates and their departure arrangements are well planned and attended to.

It is important also, to ensure that the welfare of the volunteers are considered carefully and that they are taken care of in fair manner in return for their hard work and contribution.

### Challenges

In an era when postal revenue is rapidly declining, Philatelic exhibitions are now deemed as an activity that might not benefit postal authorities directly. Currently, the survival of the Korean Philatelic Federation depends solely on the sale of Woopyo magazine as supported by the government. If the Woopyo magazine supply was to be partially reduced or completely abolished through financial restructuring, the Federation would have to close its doors immediately.

New solutions will have to be found. It is encouraging to know that in other countries like Japan, although postal services had been privatized, the Japanese government had still allocated over 90% of its budget to the PHILANIPPON FIP Recognition Exhibition in 2021. The reasoning was that, since a large-scale Philatelic Exhibition was held only once every ten years, it was acceptable to support the festival as a celebration for collectors who have consistently purchased stamps, regardless of the face value of the stamps.

The traditional viewpoint of stamp exhibitions purely from a cost-benefit perspective needs to be reformed and recalculated. In order to change this perspective, it is perhaps essential for all National Federations and general collectors to participate more actively and contribute as volunteers to demonstrate that they are not merely passive recipients.

We also need the support of collectors for Philatelic exhibitions, in order to ensure that there is still future for Philately.

## EuroPhilEx 2025 Updates

The United Kingdom will host the next European stamp exhibition, EuroPhilEx 2025 from Wednesday, 7 May until Sunday, 11 May 2025. However, the venue will not be in London but at the National Exhibition Centre in Birmingham.

The National Exhibition Centre is a purpose-built exhibition complex, easy to reach with Birmingham International Station (just over a hour train journey from central London) and Birmingham International Airport both close by. For those driving, it is situated close to several motorway junctions and has 16,500 car parking spaces with shuttle buses to the venue.

On the opening day, 7 May, the exhibition will be open from 11am to 6pm, and admission will cost £10, with early bird admission from 10am for £20. On all other days admission will be free, the exhibition being open from 10am to 6pm on Thursday, Friday and Saturday, and from 10am to 4pm on Sunday, 11 May.

There will be over 60 stand holders present, including a stand for Royal Mail. In addition, there will be stands for the Royal Philatelic Society London together with the Global Philatelic Network, a youth zone organised by the Stamp Active Network, a seating area sponsored by the Great Britain Philatelic Society, and a Literature Entries Lounge sponsored by The Stuart Rossiter Trust.

There will be 2,000 frames of exhibits from more than 30 countries, with exhibits ranging from Traditional and Postal History to Astrophilately and Maximaphily. The Court of Honour will feature the world's most valuable stamp, the British Guiana 1c black on magenta of 1856, being shown by courtesy of Stanley Gibbons, together other exhibits of great rarities.

Thursday, 8 May will be Society Showcase Day, with no fewer than 44 societies having tables, while several societies will also be holding meetings during the exhibition.

## Report for BALKANFILA XX Under Partial FIP Sponsorship

We are pleased to announce the successful conclusion of the regional philatelic exhibition, Balkanfila XX held from 13 – 16 November 2024. The event provided an excellent opportunity for the philatelic community of Southeast Europe to meet in Thessaloniki, Greece, fostering the ideals of unity, friendship, understanding, and cooperation.

Balkanfila XX was organised by the Hellenic Philatelic Society of Thessaloniki, under the patronage and support of the Hellenic Philatelic Federation, partially sponsored by the FIP, and recognised by the European Philatelic Federation (FEPA).

The exhibition was held at Pavillion No. 6 of the HELLEXPO, a renowned international fairgrounds complex located within walking distance from the city centre. It offered ample space for setting up the exhibition frames, provided uniform lighting for the exhibits, allowed easy access for loading and unloading, and included additional areas for dealer tables, and presentations. The frames were supplied by the Hellenic Post (ELTA), as is customary for philatelic exhibitions in Greece.

Accommodation for National Commissioners & Jurors was arranged at the nearby ABC Hotel near the venue.

All eleven member countries of the Balkanfila Working Group participated in the exhibition, each represented by their respective National Commissioners: Albania, Bosnia & Herzegovina, Bulgaria, Croatia, Greece, North Macedonia, Montenegro, Romania, Serbia, Slovenia, and Turkey. Additionally, three countries with close philatelic ties to Southeast Europe and/or East Mediterranean— Cyprus, Italy, and Israel—also participated, similarly represented by their National Commissioners. Exhibits related to the region were also submitted by exhibitors from Algeria, Canada, China, Indonesia, France, Germany, the United Kingdom, and the United States of America, bringing the total to 22 countries. The exhibition featured approximately 700 frames, 600 of which were in competition. A strong Literature Class comprised 40 exhibits.

The international Jury was led by the four-member Presidium, which included Honorary President and Consultant Peter Suhadolc (FIP, Slovenia), President Eddie Leibu (FIP, Israel), Vice President George Thomareis (FIP, Greece), and Secretary Emmanouil Koutsounakis (Greece). The Jury also included nine Additional members, Vladimir Milic (Serbia), Boncho Bonev (FIP, Bulgaria), Bruno Crevato-Selvaggi (FIP, Italy), Mehmet Akan (FIP, Turkey), Alexis Papadopoulos (FEPA, Greece), Alexandru Bartoc (FIP, Romania), Julije Maras (FIP, Croatia), Igor Pirc (FIP, Slovenia), and Nikos Mallouchos (Greece).

## Collecting and Exhibiting First Day Covers

In December 2024, FIAP hosted a very successful experimental competitive first day cover (FDC) class at the Shanghai Asian exhibition and this highlighted both the potential for and problems of the first day cover (FDC) exhibiting class.

Exhibits from Australia, Bangladesh, China, India, Malaysia, Nepal and New Zealand were shown. The enthusiasm for participating in the FDC class reflects the growing interest in the collecting and study of first day covers. Whilst exhibiting FDCs at national exhibitions in the United States is well-established and developed, it is much less established in other countries and currently there is no universal and consistent set of guidelines and rules for preparing and judging FDC exhibits.

### The U.S. CIPEX Souvenir Sheet of 1947

#### Development, Production, First Days and Contemporary Use

**Goal;** To tell the story of the souvenir sheet issued for the Centenary International Philatelic Exhibition (CIPEX) in New York City, May 17-25, 1947, to celebrate the 100<sup>th</sup> Anniversary of U.S. national postage stamps released in 1847; with special focus on First Day cachets.

**Context:** The 15c sheet was released on the 3<sup>rd</sup> day of the show. Both the exhibition and the sheet generated strong collector enthusiasm and a broad array of first day items.

**Idea and Design Concept:** The idea for a souvenir sheet to honor the first U.S. stamps grew from a late 1939 proposal approved by Pres. Roosevelt to recognize in 1940, the world's first postage stamp issued by England in 1840. FDR gave the Post Office Department (POD) guidance on the design of a sheetlet, as shown. It was decided that it would be inappropriate to picture another nation's stamp, so the sheet pictures the first U.S. stamp.

Despite the issue having been announced by the POD, development was cancelled in April of 1940 by Postmaster General (PMG) Farley as war clouds enveloped Europe and strong isolationist sentiment rose in the U.S.

After the War's end, the CIPEX organizing committee asked the POD to issue souvenir sheets at the show in honor of the first U.S. stamps. The PMG approved the idea on May 29, 1946. This sample layout for the sheet by the POD was submitted to the committee for reaction. They added the only "Centenary" to the inscription.

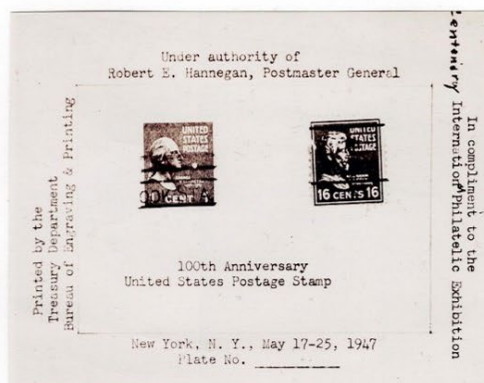

### **The importance of a first day usage**

As early as May 1840 and the introduction of the Penny Black, the significance of a first official day of usage was recognized. Robert Cole, a London solicitor with an interest in postal history prepared a first day cover for himself on 6<sup>th</sup> May 1840. His collection of postal history including his 6<sup>th</sup> May 1840 cover was sold for the first time by Christie's in London during the 1980's. Although earlier known usages for the Penny Black on 1<sup>st</sup> and 2<sup>nd</sup> May, are known the importance of 6<sup>th</sup> May usages is undiminished.

Many early stamp issues do not have an officially designated first day. In such cases, the earliest documented use (EDU) takes the place for a first day cover. In one sense, a first day cover is a category of earliest documented use. Earliest documented use can be subject to changes based on further research and new discoveries. In some cases, FDCs might be fortuitous commercial covers and in other cases the FDC might be specially generated either by a dealer or collector.

Obviously, FDC's can relate to individual stamps, sets or series of stamps or to postal stationery.

### **The key features of an FDC**

The two key component parts to an FDC are the cachet (if present) and the postmark.

There are differences in understanding as to the definition of the two key features of an FDC. Many collectors do not understand what the cachet is, and how it is different to the postmark. Many early FDCs had no special inscriptions printed or written on the envelope. The cachet represents the wording or illustrations added to the envelope prior to mailing or added later. Cachets could comprise simple lettering or more complex illustrations. Such cachets might be applied by different processes including hand stamping, lithography, photogravure, thermal printing, intaglio or manuscript. The cachets might be generic (applicable to multiple stamps or stamp issues) or specific to the stamps affixed to the cover. In the United States, cachets were introduced by Fullerton in 1909 and in Great Britain the first illustrated FDC is from 22<sup>nd</sup> June 1911. In the United States there are a very large number of cachet makers who have been active since the first cachets in the early 20<sup>th</sup> century. For most every other country the range of cachets available is much more limited. In some cases, the cachets may be officially prepared by the post office, or they may be private cachets prepared by a dealer or collector. For some American cachet makers artwork and production material is available but for others and for most countries apart from the United States such artwork is not available in private hands. An aspect of FDC collecting which has assumed greater importance in recent years is the advent of add-ons. Add-ons comprise cachets added at a much later time than the mailing of the envelope and it being serviced as an FDC. Many of these add-ons are either laser printed or by hand painted. Whilst such covers are collectable, a collector needs to be aware of their non-contemporary nature and that in some cases they are produced in quantity.

The second key component for an FDC is the postmark. Early FDCs did not have a special cancellation, and the postmark will be a simple generic town cancellation. In the United States first day of issue cancels were only introduced in 1937. In other countries, they were only introduced at a much later date. Today, most FDCs have an associated special postmark often including the wording first day of issue. In FDC collecting, it is important that the postmark should be clearly impressed and have a legible date.

### **Collecting FDCs**

As with all categories of philately, in simply collecting FDCs an individual has the freedom to collecting in whatever manner and with whatever scope they wish. They might choose to collect only unaddressed FDCs, or they may include addressed versions in their collection. Those which are addressed might have a printed, typewritten or handwritten address. One might also collect FDCs related to other events such as stamp shows, historical events or locations but souvenir covers without a direct first day connection would not normally be included in a collection of FDCs.

### **Exhibiting FDCs**

As an exhibitor of FDCs you must read and study the rules and guidelines for the specific exhibition at which you propose to exhibit. You must conform to those rules and regulations for success in exhibiting. Currently, there is no consistent and universal set of rules and guidelines for exhibiting FDCs. Currently, there are three different national guidelines and rules in addition to the IREX for the Shanghai exhibition. As yet, the FIP does not have any agreed set of regulations.

### Conflicting Guidelines, Rules and IREX

There are significant differences between the principles of exhibiting FDCs given in the APS *Manual of Philatelic Judging and Exhibiting*, (7th Edition), the guidelines of the Australian Philatelic Federation and the All-China Philatelic Federation and the IREX adopted for Shanghai 2024.

Summarizing the major areas of disparity between the four sets of principles:

#### 1. The United States:

The United States (US) has a well-established and developed FDC exhibiting category, but it is not transferable in its present form to the FIP, FEPA, FIAF and FIAP exhibiting system. Within all the Guidelines, Rules and IREX, the common thread is the emphasis upon a complete and logical story detailing the story of the stamp from conception to contemporary use. This applies both to single and multiple frame exhibits.

Under the US guidelines, the treatment of the FDC exhibit should mirror that of a traditional exhibit developing the story from the design process and production of the stamp(s), including production errors and varieties, through the initial post office announcement and related supporting documentation, the cancellation and cachet studies associated with the first day of issue and, finally, contemporary commercial uses. Postal stationery could also be treated in a similar manner. Given the very large number of cachet makers in the US, the cachet section would normally be extensive. The use of add-ons, maximum cards and other issues are not explicitly addressed.

Following the US guidelines, most FDC exhibits formed in the US correspond with the traditional exhibit approach but there is a fundamental problem with this traditional exhibit approach. Essentially such exhibits, though they may be more than 50% FDCs, ARE NOT FDC exhibits, but are simply an extension of the conventional traditional class exhibits. Within the US at national level there are no designated classes, and such exhibits do not pose a problem, at the international level with clearly designated classes, such exhibits should be transferred to and judged within the traditional class.

Alternative approaches under the US guidelines comprise a study of a single cachet maker and would study the chronological evolution of their career. The use of FDCs to tell a postal history story is also possible, but the key question is that of completeness in the postal history story. There is also some scope for the use of FDCs to tell a thematic story but the purpose of such an exhibit needs to be clearly defined on the title page and in the synopsis.

Looking at the judging criteria, under the US guidelines in terms of knowledge, a detailed knowledge and discussion of the cachet makers is expected.

A rhetorical question under the US guidelines relates to how importance is defined. What is the relative significance of production materials relating to the stamps, the first day envelopes themselves and the commercial uses shown.

Most details of presentation remain the same for FDC exhibits as in other categories, but overlapping is an accepted approach provided key cachets, postmarks or stamp aspects are not covered up. Such overlapping is not considered appropriate under some of the other guidelines.

Under the US guidelines, FDC exhibits in most cases simply mirror traditional, postal history or topical exhibits in their treatment, but given the traditional nature of most US FDC exhibits, the US guidelines are of limited use in preparing guidelines to be used by the FIP. That said, unless FIP wishes to exclude what is a vibrant and increasingly popular field of exhibiting in the US, this issue needs to be addressed.

As an aside, the recent book by Andrew McFarlane lays out the practices of FDC exhibiting from the US perspective. This book extending to 514 pages sets out best principles only from the US perspective and it does not fully account or provide for alternative approaches to treatment nor does it account for the fact that the availability of material for exhibiting FDCs of US commemorative (or special) stamps is unique to the US and is not compatible with what is available for other countries. The size of the book potentially makes FDC exhibiting intimidating and may also reduce innovation in exhibiting.

Note: The book represents the author's opinions as to good practice. Others in the field do not necessarily agree with all the author's advice.

## 2. Australian Philatelic Federation:

The Australian regulations are broadly similar to those of the US. However, they are not explicit about whether material in the design or production and development of the stamp(s) or postal stationery should be included. Under section 3.1.6 they discuss supporting material, but it is unclear if this is in relation to the cachet on the cover or to the adhesive or indicia. The guidelines group together thematic and topical exhibits although these are fundamentally different. The guidelines also allow for the inclusion of (first day) maximum cards, but only under these two headings. The classification of the exhibits (section 3.1.7) is very broad including special event covers (vi) whilst the all-embracing "[a]ny combination of the above (viii) is unhelpful.

For thematic or topical exhibits there is a stated requirement for a separate plan of the exhibit. This is confusing in that for any exhibit there should be a clearly defined plan. This requirement appears to be simply mirrored from thematic class exhibition guidelines. It is not stated whether a plan is expected for exhibits adopting a traditional treatment.

The criteria for the evaluation of exhibits also seems to simply mirror that of the other categories of exhibiting.

The bottom line is that the Australian regulations go into inordinate detail and many of the details are unclear or poorly defined. For example, the quote “[t]he philatelic knowledge will be judged according to the interest of the comments.” Equally, some of the guidelines are very helpful including the statement that rarity should be based on difficulty of acquisition.

#### 4.2 Images as Free-Form Art

### 3. All-China Philatelic Federation (ACPF):

Under the Guidelines for Judging First Day Cover Philatelic Exhibits by ACPF (Trial Implementation), it is explicitly stated that materials shown can be items “without actual mailing” - hand-backs. Further the guidelines state clearly that FDC exhibits must be composed solely of FDC philatelic materials. This gives a significantly narrower scope / treatment than under the US or Australian regulations. Under article 2.2 the discussion centers around a “thematic” treatment - neither topical nor traditional. Artwork and production materials are only allowed for the cachets or postmarks but not for the stamp(s). Under article 3.5, it seems that postal stationery, meter marks and maximum cards are not appropriate for a FDC exhibit.

Under article 4, there appears to be a contradiction in the title for the Article between Criteria for Evaluation and Methods of Organizing Exhibits. Further, it is unclear what exactly is meant by 4.3 Study and research as a method of organizing an exhibit.

Further confusion arises with article 6.3 wherein it states “[e]xhibits should focus on the study of postmarks”. Such a limitation is not appropriate for US focused FDC exhibits where there is a single official city for FDC’s of a given issue and all postmarks will be the same.

Under article 6.3 section d “[f]or stamps without a clear date of issue, the earliest use can be exhibited”. Under this interpretation, the New Zealand exhibit should have remained in the FDC class in which it was entered.

The ACPF guidelines directly contradict the other guidelines cited herein on a number of issues.

### 4. China 2024 Stamp Exhibition IREX:

The IREX adopted for China 2024 are briefer and probably clearer than those used in the US or Australia. Most of the details are similar to those used elsewhere but they are more restrictive in certain details.

Specifically, the IREX state that FDC exhibits must be composed solely of FDC philatelic materials. Although archival materials related to production of the cachet on the covers may be included, the exhibit should not include production material related to the creation of the stamp(s).

In some cases, the wording is unclear - for example article 3.4, but these issues of language can be easily addressed.

Moving forward, it is essential that the FIP IREX for FDC exhibits should be as consistent as possible with the various national guidelines and any major discrepancies should be avoided.

### **The Structure or Treatment for a FDC Exhibit**

The exhibits shown in Shanghai were very helpful in illustrating the different approaches to treatment that can be applied to an FDC exhibit. The four basic approaches, with examples from the Shanghai exhibition are:

1. A topical approach - The Great Wall, Asian Games, Infectious Diseases, Olympic Games.
2. A study of different stamp issues from one country over a specified time period - various exhibits of People’s Republic FDCs, Austria, Australia and the exhibits of Post - Independence India.
3. A detailed study of a single stamp or stamp set - “The First Day Covers of the Chinese Resistance Stamp issued by the US in 1942” (Scott number 906), “1937 Straits Settlements Commemorative Issue of the Coronation of King George VI:”
4. FDCs as postal history - the New Zealand exhibit which sought to show earliest uses where no “specific first day” is recorded and the exhibit “China’s first set of Stamps for Special Use by Compulsory Servicemen stamps First Day Cover”.

No exhibits following the US style of exhibiting as an extension of the conventional traditional class were shown nor were there any exhibits comprising of a study of a specific cachet maker.

Although FDC exhibits should include a major focus on the cachets, disappointingly this was not the case with most of the exhibits shown in Shanghai. This suggests a problem with the guidelines and IREX or the interpretation of these by the exhibitors and the judges.

**Judging Issues in Shanghai**

There seemed to be a divergence of opinion in the interpretation and implementation of the IREX in Shanghai. This is something that moving forward the FIP needs to avoid.

Individual judges may not be intimately familiar with the range and scope of material which might be available for an FDC exhibit for specific countries, time periods or topics and they may therefore have problems in applying the normal judging criteria.

Two exhibits in Shanghai appeared to be problematic for the jury. In the case of the New Zealand exhibit, it seems that the judges found difficulty in assessing this as a FDC exhibit given that it was transferred to postal history. The exhibit “China’s first set of Stamps for Special Use by Compulsory Servicemen stamps First Day Cover” did not have a FDC treatment and although judged as an FDC exhibit, it would perhaps have been better judged as postal history.

**Judging Criteria and Proposed Point Scores for FDC Exhibits****Treatment for FDC Exhibits**

- The appropriate treatment for an FDC exhibit will vary based on the available material for specific countries, periods or topics
- United States style of FDC exhibiting follows the established traditional judging class
- Topical and thematic based treatments should be judged as such
- Organize cachets in a logical and interesting manner
- Appropriateness of the material included
- Exhibits need a well-designed title page with a purpose statement and plan / table of contents addressing such aspects as non-contemporaneous add-ons, commercial uses which are not FDCs, production material for the stamps and para-philatelic material
- Effective use of headings

**Knowledge, Personal Study and Research for FDC Exhibits**

- Selection and description of material shown
- Research sources listed
- Identify new discoveries
- Correctly identify production process of cachets
- Analysis of the postmarks where relevant
- Correctly identifying non-contemporaneous add-ons
- Show unusual uses – airmails, foreign destinations
- Show unusual postal markings - auxiliary markings, unofficial cancels

**Condition for FDC Exhibits**

- Covers shown should be in the best possible condition
- In many cases the condition will be very good
- Covers which transited the postal service may show minor wear
- Cancels should be clearly impressed with legible dates
- Stamps should be tied to the cover
- Stamps should not have obvious faults or defects
- Covers should not be toned or stained wherever possible

**Rarity for FDC Exhibits**

- Assess rarity from a multidimensional perspective embracing the stamps, the cachets and postal markings
- Does not equate to the value of the stamps on the cover
- Consideration to difficulty of acquisition
- Should always be specifically quantified, citing census sources
- Avoid terms including scarce, rare, unusual
- In a study of a single stamp or set of stamps with many different available cachets, you cannot assume that all covers are equally readily available

#### Presentation for FDC Exhibits

- Many recommended aspects, some are personal preference
- Most derive from other exhibiting classes
- Concise write up
- Highlighting key items
- Quality mounting materials
- Choice of page color and ink color
- Overlapping of covers or not
- Avoid repetitive appearance, balance within and between frames

#### How do you define Importance for an FDC Exhibit?

- Difficult to assess and very subjective
- Difficulty of acquisition is hard to define
- All-China guidelines define it as the philatelic value of the exhibit
- Under the US guidelines, importance is generally related to the thoroughness of treatment
- Given its duplicative nature, Importance should be eliminated from the judging criteria
- Reallocate the points equally between treatment and rarity

#### Proposed Judging Criteria and Point Scores for FDC Exhibits

No specific points would be allocated to the plan for thematic or topical exhibits as in Australia.

#### The FIP Moving Forward with FDC Exhibits

Although placing FDC exhibits within a broader promotional class might have initial appeal, this would be the wrong approach. Given the broad appeal of FDC collecting it should be created as a stand-alone class with its own identity.

A committee should be appointed to draft a clear and concise set of guidelines and IREX for the FDC class. These should incorporate the best ideas from the different national regulations but allow for the differences in the available material for different countries, time periods and topics.

An on-line virtual training program should be offered to FIP qualified judges for the FDC class.

At the first opportunity, the FIP should promote an experimental FDC class at a future international exhibition.

To assist with the introduction of the FDC class, the FIP web site should be updated to include information about the proposals. Sample exhibits should also be shown.

Given that FDC exhibits would be well suited to virtual presentations, the FIP should consider hosting their first virtual exhibition comprising only FDC exhibits.

One of the key questions is how to differentiate the FDC class from postal history and from the traditional class. The obvious answer is that FDC exhibits must focus on the cachets associated with the FDCs. The need to focus on the cachets should be explained carefully in the draft IREX. Naturally, there are many other details which need to be clearly explained in the IREX.

The FDC class would make the FIP more inclusive and would provide a competitive arena for the growing number of collectors with an interest in collecting FDCs,
